NOTES FROM THE TRUSTEES

There's much news to share. As many of you know, we have moved the bar into our temporary quarters – which is the front portion of the ballroom. Those who have visited seem to like the light and spacious feel – which is also what the new bar will offer. As part of the move, we are now offering Happy Hour from 4-6 pm every day, with \$2 domestic bottled, canned and draft beer. Come down, bring a friend (potential new member), and see what is happening.

By the time this reaches you, we should be well underway with the Remodeling Project. Construction was set to begin March 3, but due to some contractor issues and a delay in obtaining our Grand Lodge Permit, it has been pushed to March 17. Our contractor will use the week before to move needed materials and equipment on site. The schedule of Lodge closures and/or limited or no restaurant service is a fluid item. Due to dust, electric and sewer disruptions during construction we may not be able to offer full services, and unfortunately, we may not have much advanced notice. Check the Charlottesville Elks 389 Facebook page for updates and other information. Along these lines, also be aware that there will be certain times when the poolside handicap ramp and entrance may be unavailable for access. During those times, handicap entry can be through the ballroom doors. Martin-Horn has requested that members refrain from entering the construction area. Unauthorized entrance will disrupt construction activities and perhaps create a safety issue.

We are going to offer some entertainment on select Wednesday evenings, as in the past. One benefit of our temporary quarters will be the additional space we have available for the entertainers and members/guests. Kudos to Sara Thomas and her Entertainment Committee for their efforts on this. See a listing of dates and performers elsewhere in this Piedmont Elk.

The Trustees have decided that Pool use will be free again this year. Members are reminded that they must accompany their guests, and that they are responsible for their behavior. Last year, we had complaints about inappropriate and foul language, as well as trash being thrown over the fence, and glass in the pool area. We intend to monitor this matter, and violators may be asked to leave for the day and/or be referred to the House Committee for handling.

We still have a few TV sets which you can sponsor or dedicate "in memory of" someone. Only one name/plaque will be placed on each TV. Sponsorship costs \$500.

On a personal note, I have enjoyed serving as Trustee this past five years, and wish to thank my fellow Trustees, and all of you who supported and gave me suggestions - as well as complaints. We are an organization of almost 450 members, and everyone has a vote and opinion that should be shared and considered. This will be my last "Trustee's Notes", and I have appreciated the opportunity to share information on YOUR Lodge.
